The Faculty of Law has done well in national and international rankings and won most of the awards at the National Scientific Student Associations' Conference.

BRIEF HISTORY

It was a milestone in the history of the University when in 1667, the combined estates of Imre Lósy and György Lippay, both of them cardinals and archbishops of Esztergom, were used to found the Faculty of Law. Alongside canon law and Roman law, emphasis was placed on teaching Hungarian substantive law and procedural law. Tenets of *jus commune* were taught expressly to rectify the shortcomings and crudeness of domestic jurisprudence at the time. The teaching of Hungarian law began in 1672 in two departments. The subject of the theory of Hungarian law included Hungarian substantive law, and the practice of Hungarian law included the law of legislation. Until the *Ratio Educationis* was issued (1777), tuition took place at five departments: the Department of Roman Law, the Department of Canon Law (both operated right from the beginning), two departments where Hungarian law was taught and the Department of Natural Law.

A new curriculum was introduced in the wake of the *Ratio Educationis*. In addition to the tenured instructors, so-called extraordinary instructors could be hired to ensure the teaching of new subjects. The instructor of Roman law had to teach criminal law as well, and the instructor of Hungarian law had to teach, among other things, statistics about the countries of Europe and principles of Hungarian public law. Efforts were made to establish a department of the history of Hungarian law, but Empress Maria Theresa refused permission. With time the assortment of subjects multiplied. Most of the new subjects were proposed by the Court in Vienna, but the study of Hungarian law and the history of Hungarian law also developed with some delay. There was no direct correspondence between the number of subjects and departments, as some professors taught three or even four subjects. Once a subject gathered a strong following, the related department was soon set up. By the twentieth century, it had become established that programmes taught as majors had a department of their own in all cases.

Today the Faculty has 16 Departments, the Center for Theory of Law and Society and the Institute of Political Sciences. The Faculty of Law trains *Juris Doctors* and a relatively smaller number of political scientists, public administrators, and criminologists.

RULES

MONROE E. PRICE MEDIA LAW MOOT COURT COMPETITION 2022/23 COMPETITION YEAR – EXTRACT –

7.2 General Scope of Oral Pleadings

- a) Each team shall prepare two (2) Oral Pleadings (one for each speaker) on behalf of the Applicant and two (2) Oral Pleadings on behalf of the Respondent.
- b) Each team shall have forty-five (45) minutes to present their arguments, including time for answering questions from adjudicators and rebuttals or sur-rebuttals.
- c) The order of the pleadings in each Oral Round at all levels of the Competition will be: Applicant 1, Applicant 2, Respondent 1, and Respondent 2 followed by the Applicant's (any one oralist) rebuttal and then the Respondent's (any one oralist) sur-rebuttal.
- d) Only two (2) team members shall present the arguments during an Oral Round on a team's behalf.

7.2.1 Time Allocation

- a) The first team member presenting must inform the bailiff of the manner in which the team wishes to divide its forty-five (45) minutes between its (i) first Oralist, (ii) second Oralist, and (iii) the rebuttal (for Applicant) or Sur-rebuttal (for Respondent). The time allocation informed to the bailiff may under no circumstances be rearranged.
- b) Each team's Oral Pleadings cannot exceed forty-five (45) min-

utes, including the rebuttal or sur-rebuttal.

- c) Each team may divide its forty-five (45) minutes as it deems best provided that:
 - i. No oralist is allocated less than fifteen (15) minutes or more than twenty five (25) minutes for presentation of main arguments
 - ii. No more than five (5) minutes are reserved for its rebuttal or sur-rebuttal.

7.4.2 Communication and Activity at Counsel's Table

- a) During each Oral Round, one (1) additional Team Member may sit at counsel's table with the two (2) oralists; this individual shall be called "of counsel". Only individuals registered as team members pursuant to Rule 3.2 may act as of counsel. A team's coach cannot act as of counsel.
- b) A maximum of three (3) team members may be seated at counsel's table: the two (2) oralists and one (1) of counsel.
- c) Communication between the Oralist presenting a team's arguments and her/his team's counsel's table is prohibited during presentation.
- d) Communication at the counsel's table among other team members shall be in writing, and teams shall avoid all unnecessary and inappropriate behavior which disrupts or detracts from the Oral Pleading in progress.

● **Dr. Boglárka Benkó**

holds a master's degree in law from Eötvös Loránd University, a Master in Human Rights from the University of Strasbourg and a Master of European Law from the College of Europe (Bruges). Before joining the Registry as a lawyer of the European Court of Human Rights in 2012, she worked at the Ministry of Foreign Affairs of Hungary as Desk Officer for International Organisations and at the OSCE Mission to Bosnia and Herzegovina as Human Rights Officer. is an Assistant Professor at the Faculty of Law of the University of Pécs, Department of Technology Law and Energy Law. His research field is related to ICT law and administrative procedure law, the openness and transparency of administrative proceedings, and in particular, legal issues of emerging technologies. In the past years, he was a member of the jury in the regional and international Rounds as well. He also gained legal knowledge working in top tier international law firms in Budapest.

● **Prof. Assoc. Dr. Oriona Muçollari**

is a lecturer at the Faculty of Law of the University of Tirana. Beyond her active participation in many national and international scientific conferences and publisher of many scientific articles, she has realised, as the first author, the publication of two textbooks in the field of human rights and local government, as well as co-author in the field of protection against discrimination, a textbook for students of the region in English. For several years and on working as a trainer in the field of International Human Rights (Gender balance, Discrimination, Hate Speech, Participation in Democracy, Reproductive Rights), she worked for different international and national institutions, such as the Council of Europe, UNFPA, Ministry of Education and Ministry of Youth and Sports. Dr. Muçollari is the trainer of students in moot courts in the field of human rights at national and universal level.

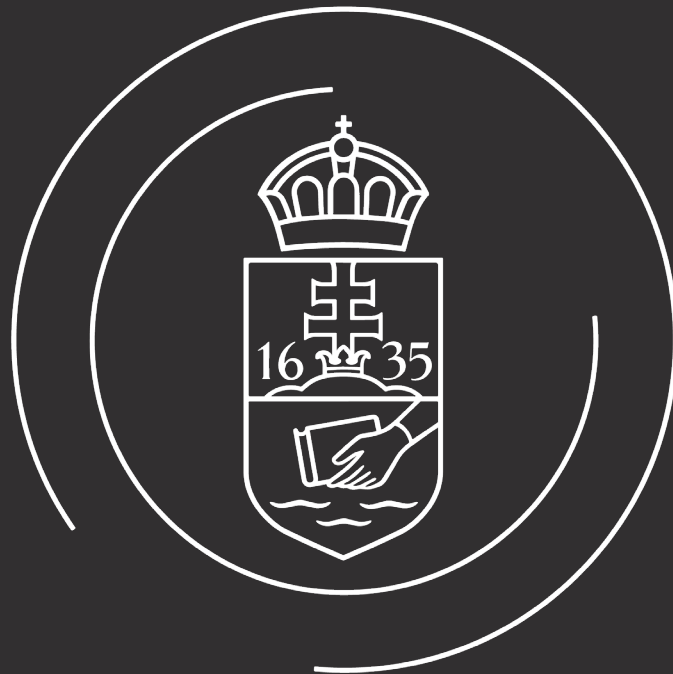
